VOTE "NO" ON THE OVERRIDE OF SB 2474

Closes Underutilized, Empty State Facilities, Saves Jobs, and Protects Children

Approximately \$70 million in savings in Fiscal Year 13

- These facilities are underutilized and empty. Murphysboro does not contain any youths; it is totally empty. Tamms only contains around 200 prisoners. Existing facilities, such as Pontiac and Menard, can absorb and manage Tamms' population. Women at Dwight will be safely transferred to Logan, and 150 youths at Joliet will be safely transferred to St. Charles.
- **Keeping facilities open will result in 530 layoffs at DCFS.** Conversely, Corrections and Juvenile Justice Employees will NOT LOSE THEIR JOBS. Each employee has been, or will be offered, a position at an existing facility, unless they do not want to continue working for the State. Keeping facilities open eliminates jobs; closing them saves jobs.
- **Keeping facilities open will harm our most-at-risk children across the State.** By funding underutilized, outdated facilities, no money can go towards DCFS intact family services. More children will be separated from their families before their second birthday and more children will enter costly State foster care. Fewer families will receive adoption assistance, which provides these vulnerable children with a safe, stable home. No legislative district will be immune to these drastic cuts.
- **Keeping facilities open costs money that the State doesn't have.** In this time of State budget crisis, it just doesn't make sense to keep underutilized, empty State Facilities open, when existing facilities are the cost-effective solution.
- BOTTOM LINE: We need to close these underutilized, empty State Facilities in order to have the money necessary to fund critical services to our most vulnerable children at DCFS. It's easy: Close costly facilities, save jobs, and protect children. VOTE "NO" ON THE OVERRIDE OF SB 2474.
